- 3. Consider 3 policies that you would use that could possibly reduce cigarette smoking. For each policy, consider 2 advantages and 2 disadvantages.

How much should governments intervene in the economy? – Section 4

This is one of the questions that economists the world over disagree on, but influences people's lives on a day to day basis. How much if at all should the government intervene in the economy?

Your task is to **research** both sides of the argument for and against the government imposing a tax on sugary drinks and write an essay on it.

- 'Should the UK government impose a tax on sugary drinks?' hint they have already but WHY?
- 1. Paragraph 1: **Introduction**: Explain what the problem is with the current consumption of sugary drinks
- 2. Paragraph 2: Explain the major arguments that people put forward **in favour** of taxing sugary drinks. Include the evidence from imposing this type of tax in Mexico
- 3. Paragraph 3: Explain the major arguments that people put forward **against** imposing the tax
- 4. Paragraph 4: Come to a **conclusion**: Based on the research you have done, do you think taxing sugary drinks is a good idea or not? Why?

Success Criteria:

Well-written and explained in your own words. Using the paragraph guide given above.

Make a clear judgement (don't sit on the fence) and support your judgement with sound evidence
